SDAA MEMBERSHIP APPLICATION FORM FOR 2024/25 SEASON

The following process will apply to applications from new/lapsed members for SDAA membership for the 2024/25 season that runs from 16th June 2024 to 15th June 2025 inclusive:

- a. Each applicant must complete a copy of this application form (*Please read all the notes on p2*).
- b. Completed application forms must be posted to the Registrar's address shown in the box towards the bottom of the page (*email applications will not be accepted or processed*).
- c. Application forms will be processed by the Registrar on a strictly 'first come first served' basis (*the SDAA website will be updated once all SDAA memberships and/or night permits have been allocated*).
- d. The Registrar will contact applicants with details of how to make payment and your unique Payment Reference Number (*please check your email spam folders*).
- e. Applicants will then be expected to tender payment within 5 working days.
- f. Applications will only be completed once payment has been made and any cheques have cleared.
- g. Membership documents and keys will be posted to successful applicants from late May/early June.

Please read all these notes carefully before completing your application form and making payment. Failure to complete the application form correctly or not provide the correct information will result in your application being delayed or refused. The committee has the right to refuse applications for both Membership and Night / 3 Rod Permits. Membership and Night / 3 Rod Permits will be valid from 16th June 2024 until 15th June 2025.

- Note 1 Personal information you provide will be held on the SDAA Ltd members register computer database and will not be passed on to any other organisation. If you provide phone numbers and/or an email address it will be assumed that you have no objection to these being used by the club to contact you.
- Note 2 Membership cards will not be valid unless a passport style ID has been securely attached.
- Note 3 Night / 3 Rod Permits are required to night fish at The Airman, Broom Lake and Willington Lake. Night / 3 Rod Permit holders (but not juniors) are also permitted to use three rods at The Airman, Broom Lake and Willington Lake at all times [other members (but not juniors) can only use 3 rods at these venues from 1st October to 31st March]. A membership card that includes a Night / 3 Rod Permit will be issued to those that apply for membership including a Night / 3 Rod Permit. **Applications for Night / 3 Rod Permits will be processed on a first come first served basis. In the event that Night / 3 Rod Permits are oversubscribed please indicate whether or not you would be happy with standard membership.**
- Note 4 The age limit for Junior Membership applications is restricted to persons who have reached the age of 12 but have not reached the age of 17. Juniors (aged 12-16) must be accompanied and supervised by a member aged 18 or over (authorised by a parent/guardian) occupying the same swim. The only exception is that Juniors will be allowed to fish unaccompanied in their own swim during the daytime, when a signed copy of the 'SDAA Junior Parent / Guardian Consent Form' has been processed by the Registrar (forms available from the SDAA website or by sending an SAE to the Registrar). All children under the age of 17 years can apply for **free** Associate Junior Membership (forms available from the SDAA website or by sending an SAE to the Registrar). Associate Junior Members can only fish with a single rod when supervised by a member aged 18 or over occupying the same swim. Associate Junior Members cannot vote at the AGM.
- Note 5 Junior Night Permits are required by junior members to night fish at The Airman, Broom Lake and Willington Lake. Junior Night Permit holders must be accompanied by a Night Permit holder aged 18 or over (authorised by a parent/guardian) and occupy the same swim whilst night fishing. Junior members are limited to using a maximum of 2 rods at all times.
- Note 6 Night / 3 Rod Permit holders (but not juniors) can be accompanied by a **single** non-fishing guest whilst night fishing at The Airman, Broom Lake and Willington Lake, provided they obtain a Non-Fishing Night Guest Permit in advance, which cost £25 a season. Non-Fishing Night Guest Permit Membership cards will not be valid unless a passport style ID is securely attached. Night / 3 Rod Permit holders must accompany their non-fishing guests at all times and will be held responsible for their actions. Please note that guests are not members of the club and therefore guests are not covered by the club's liability insurance. Night / 3 Rod Permit holders are only allowed a single non-fishing guest at any time whilst night fishing, but a Night / 3 Rod Permit holder may purchase more than one Non-Fishing Night Guest Permit each season.
- Note 7 Keys stamped 'A11' are required to open gates at The Airman, Broom Lake, Willington Lake, the parking area near Jordans Mill and the allotments at Little Paxton.
- Note 8 Please indicate which payment method you would prefer to use for your SDAA Ltd membership if your application is successful. Payment can be made by electronic bank transfer (Method A), or by cheque/postal order (Method B). We do not accept cash. **Please do not include payment with your application**, the Registrar will contact successful applicants with details of how to make payment along with a unique Payment Reference Number.
- Note 9 Membership applications must be made by posting this application form to the Registrar. Applications will only be processed if the official application form has been used. We will not accept or process any applications submitted by email. There is no need to include a stamped SAE, photos or payment with your application form. You can include: (i) a signed copy of the 'SDAA Junior Parent / Guardian Consent Form' to accompany applications for Junior membership applications; (ii) Associate Junior Membership application forms to accompany applications from applicants aged 18 or over.
